- ▶ **New Sentinel Landscapes Designations:** The Sentinel Landscapes Partnership, comprised of the U.S. Department of Agriculture, Department of Defense, and Department of Interior announced three new areas designated as sentinel landscapes, where natural and working lands thrive alongside military installations and ranges. These landscapes play a key role in strengthening the nation's military readiness while addressing natural resources concerns like climate change and contributing to the [America the Beautiful initiative](#). The three new sentinel landscapes are the Camp Bullis Sentinel Landscape in Texas, Southern Indiana Sentinel Landscape, and Northwest Florida Sentinel Landscape (in the SERPPAS region).

- ▶ **SERPPAS Spring 2022 Steering Committee Meeting:** The SERPPAS Steering Committee met in person on March 24-25, 2022, in Atlanta, GA, after two years of virtual meetings. The purpose of this meeting was to reconnect the Steering Committee in person, continue partnership engagement and advance the implementation of the 2021+ SERPPAS Strategic Plan, and prepare for the May 2022 SERPPAS Principals Meeting Anniversary Celebration.

- ▶ **South Atlantic Salt Marsh Initiative Workshop:** The South Atlantic Salt Marsh Initiative (SASMI) engaged over 170 interested partners in a virtual workshop (March 28 – April 1) to discuss the foundational topics and strategies that will inform a region-wide conservation plan to conserve and restore approximately one million acres of salt marsh and allow for its future migration. - (NFWF) The National Fish and Wildlife Foundation's National Coastal Resilience Fund is now open for proposals. NFWF will award approximately \$140 million in grants to create and restore natural systems in order to increase protection for communities from current and future threats from coastal hazards and improve habitats for fish and wildlife species. The DoD REPI Program is contributing up to \$15 million to this year's fund to support projects that enhance military installation resilience. - (DOE) The U.S. Department of Energy (DOE) announced the Deploying Solar with Wildlife and Ecosystem Services Benefits (SolWEB) funding opportunity, which will award \$10 million for innovative solutions and strategies that maximize benefits and minimize impacts to wildlife and ecosystems from solar energy infrastructure. - (ALRI) The Longleaf Partnership Council released the America's Longleaf Restoration Initiative Strategic Priorities and Actions 2022-2024, the fourth and final iteration of the step-down planning document that details a more focused look at short-term activities needed to advance the goals and objectives of the Range-wide Conservation Plan for Longleaf Pine. This document lays out priority actions designed to maintain and build upon the substantial momentum towards the goal of 8 million acres of longleaf pine restored by 2025, as well as ensure success for ALRI beyond 2025. - **Threatened, Endangered, and At-Risk Species**
- (FNAI) The Southeast Longleaf Ecosystem Occurrences Geodatabase version 1.2 (LEO GDB v1.2) is now available. This version is the culmination of LEO Phase 1 which focused on gathering partner data range wide and collecting new Rapid Assessment field data within 14 Local Implementation Team (LIT) areas outside of Florida.  - (NFLT) Partners helped to preserve approximately 157 acres in Putnam County, FL, located in the O2O wildlife corridor. The property is located adjacent to Etoniah Creek State Forest and within the priority area for conservation for Camp Blanding and the Army Compatible Use Buffer (ACUB) program designed to secure buffers around military installations. The property sits within the O2O wildlife corridor which provides important habitat for the Florida Black Bear and numerous endangered species, including the red-cockaded woodpecker, indigo snake, and gopher tortoise. - (USFS) The U.S. Forest Service Chief sent out a letter in December 2021 for direction on wildland fire management and response related to prescribed and managed fire. The Chief encourages and promotes using all of the tools available to reduce destructive wildfires and to be proactive by using mechanical fuels treatments and using fire to reduce fuels and risk to communities in the right place, at the right time, and for the right reasons. The letter confirms the commitment to use practices supported by science and to increase communication with communities to reduce controversy and gain public acceptance in the use of managed fire and prescribed fire for reducing fuels and creating resilient communities.
