#### • **Sentinel Landscapes**

- (OEA) The RAND Corporation has released a comprehensive review of the value of partnerships between U.S. military installations and their surrounding communities, concluding that such partnerships are beneficial to both military installations and their neighboring communities, and can lead to improved economic value and improved military-community relations. #### • **Threatened, Endangered, and At-Risk Species**

- (USFWS) The U.S. Fish and Wildlife Service (USFWS) has completed initial reviews of ten petitions to list, delist, or reclassify species under the Endangered Species Act (ESA), and found that four of those species may be warranted for listing, including the Florida Scrub Lizard. For

- **Coastal Resilience and Regional Adaptation**

- (OEA) A new report released by the Union of Concerned Scientists warns that U.S. military bases along the Atlantic Ocean and Gulf of Mexico will be increasingly vulnerable to floods and powerful storms as the planet continues to warm, and predicts sea levels to rise almost four feet above 2012 levels by the end of the century.
