# 0810 – 0850 Advancing Resilience After Catastrophe

**Purpose:** Invited speakers will reflect on two major catastrophes in the Gulf, the BP oil spill and Hurricane Katrina. Both had extensive negative impacts on coastal Mississippi, and both are catalysts for advancing many successful resilience efforts for the communities and the ecosystems of the region. The speakers will share lessons learned, progress made, and ways SERPPAS can chart a more equitable, sustainable, and resilient path forward in the face of continued challenges.

**Mr. James Boylan**, Branch Chief, Environmental Protection Division, GA Department of Natural Resources **Purpose:** SERPPAS has long recognized the benefits of prescribed burning as a land management tool to reduce wildfire risk and restore natural fire-dependent ecosystems in the Southeast. Military testing and training in the Southeast is critically linked to prescribed burning, as installations use this management practice for fuels reduction and to manage critical habitat for threatened and at-risk species. Climate



change is contributing to more wildfires, increasing the risk of harmful air quality while at the same time creating conditions that make prescribed burning harder to accomplish. As recognized by the SERPPAS Principals at the 2023 Principals Meeting, maintaining the ability to continue prescribed burning is of critical importance, and navigating new air quality standards will create an additional need for coordination among SERPPAS agencies. This panel will discuss these challenges and ways that SERPPAS can continue to be a leader in advancing good fire.

### Principals Engagement:

- SERPPAS was instrumental in identifying the need for the exceptional events rule process, specifically for prescribed fire. Is there support for SERPPAS taking the initiative to encourage agencies to demonstrate the exceptional events process and identify efficiencies in the context of the new EPA air quality regulation?

### 1020 – 1120 Implementing Coastal Nature-Based Solutions – Regulatory Best Practices

However, the regulatory process has presented challenges to implementation specifically in the coastal space. The SERPPAS Nature-Based Solutions Regulatory Best Practices Sub Work Group has explored the regulatory process for living shorelines to understand and share recommendations for applicants and policymakers to advance successful projects in the Southeast. This panel will contribute to the ongoing conversation from various perspectives about advancing education, capacity, coordination, and innovation for successful coastal nature-based projects supporting the DOD mission.

- Education and awareness have been the major outcomes of this sub-work group. Is there an additional role for SERPPAS in addressing these regulatory challenges? If so, what is it?
- What other types of nature-based solutions projects, either current or anticipated, might present regulatory hurdles or processes that could inform and benefit from a future focus of the sub-work group?

### 1200 – 1250 Removing Institutional Barriers For SERPPAS Success

**Purpose:** SERPPAS has set a precedent as an action-oriented partnership that finds ways to address challenges to get good work done through coordination, collaboration, and innovation. These challenges can cause delays, create barriers, or prevent good projects, in line with the SERPPAS mission, from being accomplished. Two that we've discussed today include the Exceptional Events process and the permitting challenges related to nature-based solutions projects. Two additional barriers were acknowledged by the SERPPAS work group leads and are listed below. In this session, we hope to engage the Principals on these barriers by soliciting ideas for solutions and endorsing a path forward in line with the historic accomplishments of SERPPAS.

- 1. Unprecedented volume of funding is consistently generating challenges for members in each workgroup area in the timely receipt and implementation of projects, due to things like limited manpower for processing, questions over match and co-mingling of certain funds, and the timing and release of funds.
- 2. Similar issues and bottlenecks have been identified in providing Conservation Compliance for NEPA, ESA, CWA, and others, especially in pursuing larger, landscape scale projects including multi-states, muti-military services and multi-agencies.
