## In the News

## • Spotlight

 (REPI) The REPI Program announced that the Eastern North Carolina Sentinel Landscape Partnership was selected as the recipient of the 2017 REPI Challenge award. The Partnership is a joint effort between the Army, Marine Corps, Air Force, federal agencies, state and local governments, and non-profit organizations that is coordinating to protect rural and natural lands around a number of military installations in North Carolina. The total award of \$9.2 million in REPI funds will leverage \$10.1 million in partner contributions to protect more than 17,600 acres in the eastern portion of the state.

The REPI Challenge is an annual competition that seeks to cultivate projects that conserve land at a greater scale, thereby helping the REPI Program meet its ambitious goals in spite of limited funding. Since the initiation of the REPI Challenge in 2012, \$37 million in REPI Program funds have been leveraged with \$117 million in partner contributions to protect nearly 110,000 acres of working lands, habitat, and open spaces at 12 locations nationwide.

- (ALRI) America's Longleaf Restoration Imitative (ALRI) has published an interview with the new chair for the Longleaf Partnership Council, Dr. Jim Guldin of the U.S. Forest Service Southern Region. - (USFWS) The U.S. Fish and Wildlife Service has published an article on the effort to create the Coastal Headwaters Forest project, a plan to turn 200,000 acres of mostly loblolly stands straddling the Alabama-Florida line into longleaf forest. It would become the largest, privately owned longleaf timber tract in the nation, and provide critical habitat for many threatened and endangered species which utilize longleaf pine habitat. - (REPI) North Carolina Agriculture Commissioner Steve Troxler announced that North Carolina will receive more than \$9 million in federal funding to protect areas around military bases. - (ALRI) America's Longleaf Restoration Initiative (ALRI) released its 2016 Range-wide Accomplishment Report, which summarizes the progress made over the past year toward goals detailed in the Range-wide Conservation Plan for the Longleaf Pine. (NFWF) The National Fish and Wildlife Foundation (NFWF) and the Orton Foundation, an affiliate of the Moore Charitable Foundation, have announced a new partnership that will restore and enhance the longleaf pine ecosystem in eastern North Carolina. The Orton Foundation's grant of \$300,000 will support projects through the Longleaf Stewardship Fund, a public-private partnership managed by the NFWF that provides strategic grants to expand, enhance, and

### • Threatened, Endangered, and At-Risk Species

 (USFWS) The U.S. Fish and Wildlife Service (USFWS) has completed reviews of petitions to list the Florida black bear and uplist the Mojave population of desert tortoise from threatened to endangered under the Endangered Species Act (ESA). They found that neither petition presented substantial information that the requested actions should be warranted, so no further action will be taken. For more information, visit:

- (USFWS) The USFWS filed a notice delisting the Gray Wolf in the state of Wyoming, an action taken in response to a final decision by the U.S. Court of Appeals for the D.C. Circuit recognizing the recovered status of the species. USFWS will work with state officials to transition wolf management and will continue to monitor the wolf population for the next five years to ensure recovery criteria are met. - (USFWS) USFWS has joined Florida conservation and military officials in a voluntary effort to keep the striped newt, gopher tortoise, and 20 other at-risk species from being federally listed as endangered, through a mechanism known as the Candidate Conservation Agreement with Assurances. The agreement seeks to protect and restore roughly 46,500 acres of flatwood, sandhill, and forested wetland habitat at the Camp Blanding Joint Training Center. - (USFWS) USFWS finds that the yellow lance mussel, native to waters spanning from Maryland to North Carolina, warrants ESA protection and is proposing that it be listed as threatened. The warranted finding and proposal are the result of a review conducted by a Species Status Assessment team composed of experts from state and federal government agencies as well as academic institutions. - (GTCCA) The 8<sup>th</sup> Annual Candidate Conservation Agreement for the Gopher Tortoise has been submitted to the U.S. Fish and Wildlife Service. The goal of the CCA is to organize a cooperative range-wide approach to gopher tortoise management and conservation in its eastern range. The CCA allows the signing parties to leverage knowledge and funding within a common conservation approach and framework. ## • Southeast Wildland Fire Initiative

 (FL DACS) Florida Governor Rick Scott, as well as the head of Florida's Department of Agriculture and Consumer Affairs (FL DACS), Commissioner Adam Putnam, issued a resolution recognizing April 9-15, 2017 as Florida Wildfire Awareness Week. Since the
