IN THE NEWS

• Spotlight

- ► (U.S. Endowment) The Enviva Forest Conservation Fund announced the recipients of its 2017 grants. Established by Enviva Holdings, LP and administered by the U.S. Endowment for Forestry and Communities, the Fund is awarding \$500,000 to three projects that will help conserve more than 8,000 acres of environmentally sensitive bottomland and wetland forests. The 2017 Enviva Forest Conservation Fund grant recipients are:
 - Ducks Unlimited: The Fund is providing \$175,000 to assist with the acquisition of more than 6,000 acres in Camden County, North Carolina. The property is designated as wetlands and includes pocosins and Atlantic white cedar stands, which are bottomland forest ecosystems that the Fund has designated as priority conservation targets.
 - North Carolina Coastal Land Trust: The Fund is providing \$200,000 to help acquire 1,000 acres in Bertie County, North Carolina, for creation of a new State Natural Area with public access.
 - Virginia Department of Forestry: The Fund is providing \$125,000 to support a conservation easement on more than 1,000 acres in Sussex County, Virginia. This project blends working forest uses with permanent protection of bottomland forests.

- (ALRI) The Longleaf Partnership Council released the 2016 Range-Wide Accomplishments Report in April of this year. The report documents accomplishments associated with the America's Longleaf Restoration Initiative (ALRI) in fiscal year 2016 (October 1, 2015 to September 30, 2016), as compiled by State Coordination Teams across the longleaf range from southern Virginia to eastern Texas. • Sentinel Landscapes

► (USDA) The U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) released a two-year implementation strategy to help private landowners restore and protect 400,000 acres of longleaf pine forests, a unique but imperiled landscape of the Southeast.

Through the strategy, NRCS furthers its ongoing effort to use existing Farm Bill programs and other resources to increase the abundance and improve the health of longleaf pine forests in Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, South Carolina, Texas and Virginia. - (ALRI) The American Longleaf Restoration Initiative released 2017-2018 prospects for longleaf pine cone production through the Southern Research Station's (SRS) research. Researchers predict an increase in longleaf pine production over the coming year, with some longleaf pines in Alabama, Florida, and Georgia projected to yield huge numbers of seeds in October 2017. - (USFWS) U.S. Secretary of the Interior Ryan Zinke announced \$1.1 billion in annual funding for state wildlife agencies from revenues generated by the Pittman-Robertson Wildlife Restoration and Dingell-Johnson Sport Fish Restoration acts. The 10 states in the U.S. Fish and Wildlife Service's Southeast Region will receive a total of more than \$243 million. The funds, which are distributed by the U.S. Fish and Wildlife Service, support critical state conservation and outdoor recreation projects in states such as Alabama, Florida, Georgia, Louisiana, North Carolina, and South Carolina. - (NFWF) The National Fish and Wildlife Foundation (NFWF) is seeking applications for funding under the new Central Appalachia Habitat Stewardship Program, which is dedicated to restoring and sustaining healthy forests, rivers and streams for native bird and freshwater fish populations. Up to \$1.3 million is available this year for grants in the Appalachian region of Maryland, New York, Pennsylvania, Ohio, Virginia and West Virginia. Proposals are due July 27, 2017. • Threatened, Endangered, and At-Risk Species

- ► (USFWS) The U.S. Fish and Wildlife Service will conduct five-year status reviews of 22 endangered fish, wildlife, and plants, and one threatened species, the Ozark cavefish as part of the process mandated by the Endangered Species Act (ESA). These species are found in the Southeastern United States and Puerto Rico. The five-year reviews will ensure listing classifications under the ESA are accurate and recommend changes in status where appropriate based on the latest science and analysis as well as an opportunity to track the species' recovery progress. - ► (USFWS) The U.S. Fish and Wildlife Service announced over \$1 million in grants to 37 states and the District of Columbia to help combat white-nose syndrome (WNS), a fungal disease that



has killed millions of North American bats in recent years. Funds will help states find ways to prevent the spread of WNS while increasing survival rates of afflicted species. Insect- eating bats keep agricultural pest populations down, saving farmers at least \$3.7 billion per year in lost crop revenue and preventing the need for spraying costly toxic chemicals. - ► (NWTF) The Alabama Chapter of the National Wild Turkey Federation (NWTF) donated 24 acres to the Lauderdale Wildlife Management Area (WMA) in north Alabama. The group purchased the land for \$42,000 and donated it to the Alabama Department of Conservation and Natural Resources (ADCNR) that will increase access to public hunting as well as provide habitat for multiple wildlife species including white-tailed deer and Eastern wild turkey. Putnam announced on July 7, 2017 that 41 wildland firefighters from the Florida Department of Agriculture and Consumer Services' Florida Forest Service are to assist wildfire suppression efforts in Western states. Coastal Resilience and Regional Adaptation

- (FL DEP) The Florida Department of Environmental Protection recently joined the Citrus County Board of County Commissioners, the Southwest Florida Water Management District and local officials to celebrate the groundbreaking of the Southwest Regional Water Reclamation Facility. The project is funded through a \$12.4 million loan through the state's Clean Water State Revolving Fund (CWSRF), and a \$4 million legislative appropriation grant.
