- ▶ Sea Grant/SERPPAS Coastal Resilience Workshop: The Advancing Coastal Resilience in Mississippi Defense Communities Workshop was held on February 23, 2023, in Ocean Springs, MS. About 36 participants from the Mississippi-Alabama Sea Grant Consortium, SERPPAS, Federal agencies, state, regional, and local government, installation staff, NASA Stennis, and NGOs were present. The workshop consisted of 10 informational sessions and an opportunity for breakout sessions for idea exchanges. - (REPI) The REPI Program is thrilled to announce the 2023 REPI Challenge project recipients. For the 2023 REPI Challenge, the REPI Program contributed \$24 million in funds, coupled with \$50 million in partner contributions, to advance innovative projects that limit development pressures, enhance military installation resilience, and relieve current or anticipated environmental restrictions on military testing, training, or operations. By distributing funds across 13 projects, the REPI Challenge contributed to initiatives benefiting 26 installations and their communities across the country. - (NFWF) The National Fish and Wildlife Foundation is pleased to announce the 2023 National Coastal Resilience Fund (NCRF) Request for Proposals (RFP). NFWF will make investments in planning, design, and implementation of natural and nature-based solutions. The goal is to enhance protection for coastal communities from the impacts of storms, floods, and other natural coastal hazards and to improve habitats for fish and wildlife. Limited funding is available in partnership with the DoD to support projects advancing nature-based solutions in the vicinity of but not within the boundaries of DoD installations and ranges that enhance military resilience to coastal hazards. - (SLP) The 2022 Sentinel Landscapes Accomplishments Report outlines how the Sentinel Landscapes Partnership enables the U.S. Department of Agriculture, Department of Defense, Department of the Interior, and their on-the-ground partners to combine resources and align funding to pursue mutually beneficial land use goals in sentinel landscapes. - (Avon Park SL) Conservation Florida, USDA NRCS, and DoD have conserved 1,250 acres that will protect vital wildlife habitats on the eastern edge of the Lake Wales Ridge in Highlands County, Florida. The property is a major connector piece in the Florida Wildlife Corridor, linking environmentally important and protected properties in the region. Arbuckle Creek Ranch is critical to protect and beneficial to the public because it helps filter and replenish drinking water within the Lake Istokpoga watershed, which drains into the Kissimmee River and on to Lake Okeechobee. It also supports local agriculture, aids military readiness, and provides habitat for native plants and wildlife. - (FL) Governor Ron DeSantis and the Florida Cabinet approved the investment of more than \$17.7 million to conserve more than 3,500 acres across the state. The five properties stretch from Nassau County south to Charlotte County and protect or buffer lands within the Florida Wildlife Corridor, a recently designated network of connected lands that is crucial for wildlife habitat. - (USDA) The Joint Chief's Landscape Restoration Partnership enables NRCS and USFS to collaborate with agricultural producers and forest landowners to invest in conservation and restoration at a big enough scale to make a difference. USDA will invest more than \$48.6 million this year through the Joint Chief's Landscape Restoration Partnership for projects that mitigate wildfire risk, improve water quality, restore forest ecosystems, and ultimately contribute to USDA's efforts to combat climate change. Through the new three-year projects, landowners will work with local USDA experts and partners to apply targeted forestry management practices on their land, such as thinning, hazardous fuel treatments, fire breaks and other systems to meet unique forestry challenges in their area. Coastal Resilience and Regional Adaptation

- (SECAS) With the release of <u>Southeast Conservation Blueprint 2022</u>, which replaces the standalone South Atlantic Blueprint, the South Atlantic resources have been transitioned over to a larger regional partnership—the Southeast Conservation Adaptation Strategy (SECAS). The South Atlantic LCC website has been taken down, and that web address now redirects to the SECAS website. - NCDOT Nears Completion on its First Living Shoreline Project: The North Carolina Department of
 Transportation, citing its commitment to consider nature-based solutions for resiliency, has
 partnered with the North Carolina Coastal Federation on a living shoreline project along the
 causeway between Swansboro and Cedar Point to protect N.C. 24. This living shoreline, expected to
 be completed this summer, is one of three being built along the causeway with the other two
 managed by the NC Coastal Federation. The first living shoreline was completed in July 2022 and
 the third will be built sometime this year. This project was pointed out to SERPPAS Principals during
 the mobile meeting of the 2022 Principals Meeting in Beaufort, NC. To learn more about the living

- (Pew) The Florida Department of Environmental Protection approved an extensive plan for the Nature Coast Aquatic Preserve to conserve some waters off the state's west coast by expanding water quality monitoring, restoring damaged seagrass, and encouraging community groups to work together to address pollution and other problems. The preserve covers about 700 square miles and area hosts mangrove islands, salt marshes, oysters, sponges, corals, and more than 350,000 acres of seagrass—part of the largest seagrass bed in the Gulf of Mexico. Through the new Readiness and Recreation Initiative, DOI's National Park Service will provide \$40 million in funding from unobligated Land and Water Conservation Fund (LCWF) balances to safeguard natural areas, protect water resources, preserve cultural heritage sites, and provide recreation opportunities for the public. The REPI Program will provide a matching \$40 million in funds to support projects within an existing REPI agreement area or an area that is actively developing a REPI agreement area.
