➤ SERPPAS Awarded 2023 Climate Adaptation Leadership Award for Natural Resources: We are very excited to share that on September 25, 2023, SERPPAS received the 2023 Climate Adaptation Leadership Award for Natural Resources at the Association of Fish and Wildlife Agencies Annual Meeting in Calgary, Alberta. SERPPAS was recognized in the Broad Partnerships category for exemplary leadership in reducing climate-related threats and promoting adaptation of the nation's natural resources. • We are excited to pass along the announcement of over \$141 million in grants through the new America the Beautiful Challenge (ATBC). The 74 new grants will support projects that conserve, restore, and connect habitats for wildlife while improving community and installation resilience across 46 states and three U.S. territories. In particular, we'd like to congratulate all of the partners of the "Building Resiliency of Longleaf Pine Ecosystems in Southeastern Sentinel Landscapes" proposal that was awarded \$2.5 million (Department of Interior - \$1.7M, and Department of Defense - \$814K). This proposal was led by the NC Wildlife Resources Commission, current SERPPAS Steering Committee State Co-Chair, in coordination with the other State Wildlife Agencies, and was supported by SERPPAS, SEAFWA, SECAS, each of the local Sentinel Landscapes and many more. This project supports goals and objectives in three of the SERPPAS focus areas, At-Risk, Threatened and Endangered Species, Prescribed Fire and Sentinel Landscapes, and will continue to advance important work across the SERPPAS geography. Southeast Regional Partnership for Planning and Sustainability (SERPPAS)



- The National Fish and Wildlife Foundation and the National Oceanic and Atmospheric Administration announced the recipients of the 2023 National Coastal Resilience Fund (NCRF). Through this year's NCRF, NFWF will provide \$144 million to 109 projects across 31 coastal states and United States territories, with more than \$97 million in matching contributions for a total conservation impact of \$242 million. The NCRF aims to reduce risks for coastal communities from the impacts of storms, floods, and other natural coastal hazards and improve habitats for fish and wildlife. Specifically, we would like to spotlight the South Atlantic Salt Marsh Initiative which received \$1.4 million in REPI Funds to build capacity to conserve salt marsh habitat within coastal communities. - The National Fish and Wildlife Foundation released the 2024 Request for Proposals for the Longleaf Landscape Stewardship Fund. This RFP expects to award approximately \$30 million in federal and private sector funding in support of on-the-ground projects that help accelerate longleaf pine restoration on private and public lands to support wildlife, sequester carbon, safeguard water quality, and increase forest resilience. Limited funding also is available to support bottomland hardwood restoration and enhancement activities as outlined within the RFP. Full proposals are due February 15, 2024. Sentinel Landscapes

- The Avon Park Air Force Range Sentinel Landscape, in partnership with Conservation Florida, and
 the USDA Natural Resources Conservation Service are in the process of acquiring a \$3.2 million
 conservation easement for the 1,250-acre Arbuckle Creek Ranch, a critical segment of Florida's
 iconic wildlife corridor. The ranch is within the boundaries of the Avon Park Air Force Range
 Sentinel Landscape and with this protection, will reduce residential development that interferes

► Threatened, Endangered, and At-Risk Species

- America's Longleaf Restoration Initiative announced the release of the Range-wide Conservation
 Plan for Longleaf Pine (2025-2040). This second iteration of the Conservation Plan guides the
 continued efforts to reach the goal of eight million acres of longleaf pine forest in the Southeast.
 While the strategies and objectives are updated for the next 15 years, the vision of America's
 Longleaf remains unchanged to have functional, viable longleaf pine ecosystems with the full
 spectrum of ecological, economic, and social values inspired through a voluntary partnership of
